



**FACULTY RESEARCH PROGRAMME (FRP)**

**Call for Research Proposals (2026-2027)**

**Dated: August 07, 2026**

In continuation of the commitment to support and expand its research profile, the Institution of Eminence (IoE), University of Delhi invites short-term research proposals from the faculty members of the University Departments and Centers for the year 2026-27.

- i. Research proposals are invited from the faculty members of the University of Delhi individually or in collaboration with other researchers as Co-PIs (up to one) from within/outside the University including University of Delhi Colleges.
- ii. The maximum financial assistance under this scheme for various Faculties/Subjects of the University is as follows:

- iii. The proposed study should address an intellectual inquiry with a clear hypothesis and specific objective(s).
- iv. The research proposal should have the clearly defined objectives and the expected outcomes to be achieved within the specified duration.
- v. The research work should be designed keeping in mind the already existing laboratory/software/equipment/machinery/infrastructure available with the PI/Co-PI.
- vi. The proposal is to be submitted online on the web link, namely: <https://ioe.du.ac.in/ioe-form/frontend/web/>
- vii. **The last date for the submission of research proposals is: 23.08.2026.**

**Eligibility**

- The PI must be in permanent service in the University at the time of submitting the project proposal and shall have remaining service at least up to March, 2027.
- The PI shall not be on leave for a period exceeding three months at the time of application or at any stage during the project tenure. If leave period exceeds three months and overlaps, wholly or partially, with the project period, the PI shall be ineligible for the project.
- All assets generated from the FRPs should be entered into the stock register maintained by the PI and/or Department. A certificate in this regard to be submitted while applying for the FRP 2026-2027 only for the faculty members who have less than 3 (three) years of service left in the university.

## Screening Criteria

Faculty members who are meeting the following criteria will only be considered for the FRP 2026-2027 research grant:

- **Research Publications in the past 3 years (May 01, 2023 to April 30, 2026):**

*(Criteria of screening shall be based either on the cumulative impact factor or the number of research publications as mentioned below):*

*\*The quality of research papers/publications shall be assessed in terms of SCIE/SSCI/A&HCI journals. Further, all research papers/publications must be SCOPUS indexed.*

*\*Only original research articles will be considered. Review, correspondence, commentary, letter, editorial, erratum, note, conference paper, short survey, book chapter, etc. will not be considered.*

*†At least, 50% of the publications should be in the capacity of First/Corresponding Author.*

*#A SCOPUS indexed book authored in an individual capacity by a PI shall be equivalent to 2 (two) research publications.*

*@A patent (published/granted) / technology transfer by a PI shall be equivalent to 2 (two) research publications.*

*<sup>s</sup>Research articles must be listed in UGC CARE journals at the time of publication. However, the research proposal shall be eligible for funding in case of (i) two original research articles in a SCOPUS indexed journal(s), in case FRP 2024-2025/FRP 2025-2026 was sanctioned (ii) one original research article in a SCOPUS indexed journal, otherwise.*

- The decision of the reviewer(s) and the Proposal Evaluation Committee (PEC) shall be final.
- The outcomes in terms of publications/books/patents from FRP 2020-2021, FRP 2021-2022, FRP 2022-2023, FRP 2023-2024, FRP-2024-2025 and FRP 2025-2026 shall also be considered while evaluating the proposal submitted for the FRP 2026-2027.

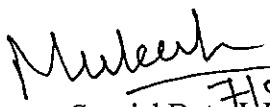
## Budget Utilization:

- Re-appropriation of the budget will not be entertained after the sanction of the project. However, the competent authority may allow re-appropriation of budget to a maximum of 10%, subject to PI providing a proper justification for the same within 60 days of receipt of the sanction letter.
- All purchases shall be done through PI's GEM Id.
- All purchases shall be made in accordance with the financial rules of the University, the General Financial Rules (GFR), 2017, and amendments issued thereto from time to time. Splitting of purchase order must be avoided as per GFR.
- The following purchases/expenditures will not be allowed under this scheme: video recording instrument, air conditioner, room heater, camera, furniture, home theatre, mobile

- phone, television, crockery, bag, webcam, yearly/life-time membership, diary, international travel, AMC etc.
- v. The purchase of a laptop within a limit of Rs. 90,000/- is permissible only through GeM, subject to the condition that a PI has not availed in past/will not avail any financial support from the Department/Centre/IoE/University of Delhi for this purpose in the next three years.
  - vi. No arbitrary expenditure on stationery or photocopying or repair of equipment shall be claimed. Furthermore, while submitting the bills of repair, the year of purchase alongwith the cost of equipment must be mentioned.
  - vii. If the project involves fieldwork, details of the field/experimental site(s) should be provided. However, the budgetary requirement for the fieldwork shall not exceed the permitted capped budget allocation.
  - viii. For fieldwork and data collection activities, the PI may engage up to two Field Investigators/Research Assistants for a period not exceeding three months. Each appointee shall receive a fixed remuneration of ₹20,000 per month. The essential qualification for such appointee shall be a postgraduate degree in the concerned or an allied subject. A certificate needs to be submitted by the PI stating that Field Investigator(s)/Research Assistant(s) engaged in the project is/are not be in his/her blood relation/close-relative and are not receiving any fellowship.
  - ix. IoE will pass Travel Allowance/Dearness Allowance claims as per entitlement/GFR 2017 subject to the following conditions: (i) a vehicle must be hired from GeM and no personal vehicle shall be used for local as well as outstation journey. In case of unavailability of a vehicle to remote location, per Kilometer (KM) rates, as notified by the University of Delhi, shall be applicable. However, the bill(s) must carry GST No. and complete travel details including distance covered in KM, (ii) prior permission for travel related to the work/project must be taken before commencing the travel, and (iii) travel-bills must be submitted within one month of completing the travel.
  - x. Travel to hometown, personal visits or travel of the collaborators shall not be admissible.
  - xi. Travel related to attending a conference/seminar (**restricted to a maximum of three conferences/seminars**) must be supported with the relevant documents (invitation letter, participation certificate, and academic outcome/relevance with the project).
  - xii. Travel related to the visit to a department/university/institute/center and necessary for the proposed research work/data collection/measurements must be supported by an invitation letter/certificate from the institution's Head/Director/Vice-Chancellor.
  - xiii. Travel reimbursement will only be considered after the duly approved leave certificate from the SAMARTH portal is submitted and tickets are purchased as per the University of Delhi guidelines.
  - xiv. The financial assistance from the IoE must be duly acknowledged in all publication(s)/patent(s), etc. obtained/published out of the FRP.
  - xv. Any misappropriation and/or wrongful utilization of funds would amount to disciplinary action against the PI/Co-PI, as per the University rules.
